S.R.O No.22/78—In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby makes the following amendments to Kerala Service Rules, namely:-

AMENDMENTS

(C.S.No.333/77)

In the said rules in Appendix VII, under the heading “Section III—Compensation Leave”.

1. in condition (ii) for the words “ten days” the words “twelve days” shall be substituted:
2. in condition (iii) for the words “two months” the words “three months” shall be substituted.
3. in condition (iv) for the figure “7” the figures “10” shall be substituted.

The amendments hereby made shall be deemed to have come into force on the 7th day of May 1973.

Explanatory Note

In the G.O.read above orders were issued to the effect that the maximum period of compensation leave taken by a Government Servant in a calendar year will be raised from ten to twelve days. The time limit for availing of the leave was raised from two months to three months. The maximum leave that can be accumulated was raised from 7 days to 10 days. The Government Order is issued to incorporate necessary amendments to Kerala Service Rules.
