Rehabilitation - Age concession to Indian Nationals migrated from East African Countries of Kenya, Uganda and Tanzania and repatriates from Zambia, Malwi, Zaire and Ethiopia for appointment in Government services - extension of period granted orders issued.

Order.

In the G.O. read above orders were issued granting age concession to Indian Nationals migrated from the East african countries of Kenya, Uganda and Tanzania and repatriates from Zambia, Malwi, Zaire and Ethiopia upto 31-12-1978 as advised by the Government of India.

2. In their letter read as second paper, the Government of India have intimated that the age concession granted to the Indian nationals migrated from the East African countries of Kenya, Uganda and Tanzania and repatriates from Zambia, Malwi, Zaire and Ethiopia have been extended upto 31-12-1979, in consultation with the Union Public service commission, and have requested the state Governments also to take appropriate action.

3. Government have considered the question in consultation with the Kerala Public Service Commission and are pleased to order that the concession regarding age allowed to the Indian Nationals migrated from East African countries of Kenya, Uganda and Tanzania and repatriates from Zambia, Malwi, Zaire and Ethiopia as per the Government order read as first paper will be extended upto 31-12-1979 for appointment to posts in the services in this state on condition that the candidates should produce a certificate of eligibility from the District Collector of the concerned District. The concession will be made applicable only from the date from which provision for this purpose is included by the Kerala Public service commission in the Gazette Notification. The benefit of the age concession will not be admissible to persons who were not actually repatriated to India and were living in this country prior to the repatriation of their parents/guardians.
