PUBLIC SERVICES— CONCESSIONS TO RELEASED N. C. C. CADET INSTRUCTORS—AGE RELAXATION FOR APPOINTMENT TO CIVIL SERVICES AND PRIORITY IN THE MATTER OF RECRUITMENT THROUGH EMPLOYMENT EXCHANGE—ORDERS ISSUED

ORDER

The Government of India have granted the following concessions in favour of the released N.C.C. Cadet Instructors:—

1. For purposes of appointment to posts, recruitment to which is made through the Employment Exchange, they will be given 'Priority III'.
2. They will be allowed to deduct from their actual age the period of service rendered by them in the N.C.C. and if the resultant age does not exceed the prescribed upper age limit of a particular post by more than three years, they will be deemed to be satisfying the condition for appointment to that post in respect of the maximum age.

They have also recommended that similar concessions may be granted to the released Cadet Instructors for recruitment to posts under the State Government.

In the G. O. read as third paper discharged State Government employees are given Category 1(e) in the order of priority for appointment to vacancies under the State Government which are filled through Employment Exchange; In the G. O. read as first paper Ex-servicemen have been granted age relaxation to the extent of their service in the Armed Forces plus the period of unemployment on discharge up to a maximum of 3 years for recruitment to various posts in Government service.

The Government direct that in the matter of giving priority for appointment to vacancies filled up through Employment Exchanges the released N.C.C. Cadet Instructors be bracketed with "discharged State Government Employees and displaced Goldsmiths under Category 1(e) in the G. O. read as third paper. The Government also direct that the age relaxation concession now available to Ex-servicemen as per the G. O. read as first paper be extended to released N. C. C. Cadet Instructors for purposes of appointment to various posts in the State Government service.
