ORDER

In the letter first cited the Government of India have informed that they have recognised the Ratna Examination conducted by Mysore Hindi Prachar Parishad, Bangalore as equivalent to the standard of Hindi of the B. A. Examination, for a period of three years commencing from 17th November, 1976. The Government of India have requested to accord similar recognition to the Examination by the State Government also.

Government in consultation with the Kerala Public Service Commission, direct that the standard of Hindi of the Hindi Ratna Examination of Mysore Hindi Prachar Parishad, Bangalore be recognised as equivalent to the standard of Hindi of the B.A. Part III Examination of the Universities in the Kerala State for purposes of appointment to Public Services in the State for the period up to 16-11-1979.
