ORDER

In the G.O. read above, orders have been issued revising the rates of D.A of employees from 1-4-1979. A doubt has been raised as to how the revised rates of D.A should be paid to employees who have opted to continue in the pre-revision scales of pay.

The revision of the rates of D.A sanctioned from 1-4-1979 is related to the revised scales – i.e. the scales of pay after merger of D.A. at 272 points. As such, the new rates of D.A. cannot be applied directly in the case of those who remain in the pre-revision scales of pay, In the circumstances, Government order that in the case of an employees who is continuing the Pre-revision scale of pay, the revised rates of D.A from 1-4-1979 will be calculated as follows;-

- (i) D.A on pre-revision pay at the rates sanctioned in. G.O. (P) 82/75/Fin. dated 4-3-1975.

**Plus**

- (ii) D.A. at the rates sanctioned at the rates sanctioned in G.O (P) 485/79/Fin.dated 25-5-1979. The percentage /rates prescribed in this G.O. will be applied to the “emoluments” consisting of basic pay in the pre-revision scales plus D.A at the rates prescribed in G.O. (P) 82/75/Fin. dated 4-3-1975 admissible thereon.
3. The total amount of D.A. admissible will be rounded off to the nearest rupee, by taking fifty paise and above as one rupee.
