The petitioners have sought the conversion of these lands on the ground that the lands have become unsuitable for cardamom cultivation.

2. Government have examined the request of the petitioners in consultation with the District Collector, Kottayam, the Special Officer, Cardamom Settlement and the Director of Agriculture and they are satisfied that the lands referred to in para 1 above, owned by the petitioners are unsuitable for cardamom cultivation, Government therefore permit the petitioners to convert the said lands into coffee, rubber or pepper plantations. The felling of the trees in the lands shall be subject to the conditions specified in G.O.(P)
