ORDER

In the G.O. read above, Government have approved a new form of Mahazar for drawing up the occurrence report as per paragraph 7.5.1 of the Kerala Forest Code Volume I read with Appendix XI Kerala Forest Code Volume III.

The following consequential amendment will be made to Kerala Forest Code Volume III:-

The first and second sentences under para 1 "Submission of occurrence report" in Appendix XI of Kerala Forest Code Volume III will be deleted and the following substituted.

1. Submission of occurrence Report

When a Forest Officer below the rank of a Range officer detects the commission of a Forest offence, he shall, within 24 hours, submit an occurrence report of the case in the form of a mahazar in form A1 (appended) to the Range Officer concerned. This mahazar should be prepared at the scene of offence immediately after the offence is detected, and it shall be got attested properly, if possible, by the accused persons and witnesses, if any, present at the site.
