NOTIFICATION

**S.R.O.NO.1348/81.**----In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:-

**Rules**

1. (i) These rules may be called the Kerala Service (Amendment) Rules, 1981.

(ii) They shall be deemed to have come into force on the 9<sup>th</sup> March, 1981.

2. In the Kerala Service Rules, in Appendix IX, under the heading “B class II, Tracts”, in the existing boundaries and limits specified for “East” under the sub heading “Nelliampathy Range”, for the words “Thence the above road “ the words “Thence along the above road” shall be substituted

## **Explanatory Note**

(This is not part of the notification, but is intended to indicate its general purport).

By G.O.(P) 159/81/Fin. Dated 9-3-1981. Government have amended the Appendix IX, K.S.R. specifying the boundaries of hilly tracts. In the amended rule the word 'along' was omitted between the words 'Thence' and 'the' occurring in the boundaries prescribed for the Eastern side of Nelliampathy Range. This amendment is intended to supply the above omission.
