### ORDER

In the Government orders read as first paper above Government have laid down that an officer who dies while under suspension shall be paid the cash equivalent of leave salary in respect of Earned Leave at his credit on the date of death if the authority competent to order re-instatement is of opinion that the officer has been fully exonerated and the suspension was wholly unjustified. But as per rule 56 B(2), Part I, Kerala Service Rules, notwithstanding anything contained in Rule 55 where an officer under suspension does before the disciplinary or Court proceedings initiated against him are concluded, the period between the date of suspension and the date of death shall be treated as duty for all purposes and his family shall be paid the full pay and allowances for that period to which he would have been entitled had he not been suspended, subject to adjustment in respect of subsistence allowance already paid.

Government have examined the above positions in detail and are pleased to order, in partial modification of the G.O. read as first paper above, that the facility to surrender Earned Leave at the credit of an officer under suspension who dies before the disciplinary or court Proceedings initiated against him are concluded, shall be decided in accordance with the provision contained in Rule 56 B(2), Part I, Kerala Service Rules.
