## Abstract

PAY-REVISION OF SCALES OF PAY- FIXATION OF PAY IN THE HIGHER POST IN THE CASE OF PERSONS WHO WERE PROMOTED ON OR AFTER 1-7-1983 BUT WHO OPTED TO CONTINUE IN THE PRE-REVISED SCALE APPLICABLE TO THE LOWER POST BEYOND THE DATE OF PROMOTION TO THE HIGHER POST-

## ORDER

According to Rule 12 of the rules for fixation of pay in Annexure III the G.O. read as first paper above, promotions or appointments made on or after Ist July, 1983 would be deemed to have been made to the revised scale of the post and pay such cases refixed, if necessary, under the normal rules.

2. In the letter read as second paper above the Accountant General (A\$E),has sought clarification as to how the pay in the higher post should be fixed in the case of persons who were promoted on or after 1-7-1983 but who opted to continue in the old scale applicable to the lower post beyond the date of promotion to the higher post.

3. Government have examined the matter in detail and are pleased to issued the following orders.

(i) In the case of an employee promoted to higher post after 1-7-1983 but Who opted to continue in the pre-revised scale of his lower post beyond the date of promotion to the higher post, his pay in the revised scale of pay in the promoted post on the date of promotion will be determined by adding one notional increment to his basic pay in the lower post plus D.A.at 488 points for such notional pay and then his pay fixed at the next higher stage in the revised scale of the promoted post, whether the amount represents a stage or not.

(ii) After fixation of pay of the employee in the lower post on the date of Option in accordance with the rules for fixation of pay in Annexure III to the to the G.O. read as first paper above, with reference to the pay so fixed his pay in the revised scale of the promoted post will be fixed applying Rule 28 A/37, as the case may be, of Part I, Kerala Service Rules.

4. Illustrations on the application of the above orders are given below.

(i)Fixation of payoff a Section Officer promoted as Under Secretary on 1-5-1985 but who opted to continue in the pre –revised scale of Section Officer up to 1-7-1985.
