PAY REVISION 1997-PAY FIXATION- JUNIOR-SENIOR ANOMALY-MODIFIED ORDERS ISSUED

ORDER

As per fixation rule appended to the Government Order read as 1st paper above the anomaly of junior getting more pay than Senior in case in where the Senior promoted prior to 1-3-1997 and the prior after 1-3-1997 has been rectified by stepping up the pay of the senior to that of the Junior from the date on which junior draws more pay than the Senior Officers.

Subsequently, as pre Government Order read as 2nd paper above , the anomaly of junior getting more pay than the senior by virtue of the fact that the Senior in promoted after 1-3-1997 before his normal date of increment in the lower post and the Junior exercised option on his date of promotion after obtaining one increment in the pre-revised scale, was rectified.

Even after the issuance of the above orders , several instances have come to the notice of Government where the junior Officer draws higher pay than the senior due to the restriction in the Government orders cited. As the Senior and the Junior Officer opted different posts in these cases , step up of pay is not admissible as pre existing rules. In these cases , all other conditions as satisfied for stepping up of pay allowed in the Government orders dated 25-11-1998 and 25-1-2000, except for the date of exercise of option to the revised scale. Since all other conditions are satisfied for stepping up of pay allowed in Government Orders read as second paper above , except for the date of option for the revised scale , Government are pleased to order that the benefit of stepping up[ordered in G.O.(P) No. 220/2000/(56) /Fin. dated 25-1-2000 will be extended to those Senior Officers who got promotion after 1-3-1997 but opted the lower post to come over to the revised scale, by stepping up the pay of the Senior equal to that of the Junior from the date on which the Junior draw more pay subject to the condition that the excess pay drawn in the revised scale with effect from 1-3-1997 till the date on which the Junior gets higher pay will be refunded in lump.
