Sub:- Public Service-Kerala General Service-Post of Driver-Filling up-Further instructions issued.

1. G.O. (P) No. 202/72/PD dated 22-5-1972.
2. G.O. (P) No. 120/73/PD dated 30-4-1973.
3. G.O. (MS) No. 42/88/P&ARD dated 3-8-1988.

Government in the G.O. read as 3rd paper above have issued the following instructions to be followed by the Head of Departments/Appointing Authorities while Drivers on daily wages are engaged:-

- (i) Permission for engaging Drivers on daily wages is available only where sanctioned post of Driver exists and Drivers on daily wages should not be appointed beyond a period of 10 days.
- (ii) Drivers on daily wages should not be engaged in cases where the vacancies of Drivers have not been reported to the Director of employment/Public Service Commission.
- (iii) Whenever purchase of a vehicle is sanctioned, such sanction should invariably contain sanction for the post of Drivers also.
- (iv) The Heads of Departments and Administrative Departments in Secretariat will expedite action for the creation of post of driver for the vehicle which have no sanctioned post of Drivers.

It has come to the notice of Government that certain Heads of Departments/Appointing Authorities are not strictly following the above instructions.

In the above circumstances, Government direct that all Heads of Departments/Appointing Authorities should follow the instructions in G.O. (P) No. 42/88/P&ARD dated 8-8-1988 scrupulously in the matter of appointment of Drivers on daily wages. Laxity if any found will be dealt with seriously.
