CIRCULAR MEMORANDUM

No. 3737/Rules-1/90/P& ARD. Dated Thiruvananthapuram, 29th March, 1990.

*Sub:-*Public Service –Re-registration of thrown out candidates for Further re-advice Instruction –Issued.

Ref:- Letter No.AV(3) 19079/85/GW dated 30-1-1990 from the Secretary, Kerala Public Service Commission .

As per the second proviso to sub-rule (b) of Rule 7 of the General Rules, in the case of posts in more than one Department/Institution for which a common selective list is prepared by the Commission, the candidate discharged from service for want of vacancies can-

- (i) re-register his name in the office of the Commission and get himself re-appointed on further advice of the Commission, or;
- (ii) await his turn for reappointment to the post from which he was discharged

2. If the candidate resorts to method (i) above and get himself re-appointed on the further advice of the Kerala Public Service Commission he shall lose right of probation to the post in the Department/Institution concerned from which he was discharged for want of vacancies, and if the resorts to method (ii) above and get re-appointed to the post in the Department/Institution concerned from which he was discharged he can continue as probationer in the post from which he was discharged.

3. In the letter cited, the Secretary, Public Service Commission has informed Government that due to ignorance on the part of the candidates of the rule position, much delay is caused now-a-days for re-registration by the discharged persons with the Commission for re-advice which, in turn, entails delay in re-appointment of the candidates. In the circumstance, all Heads of departments and appointing authorities are requested to ensure that the

formal relief of candidates other than Last Grade Servants thrown out of service for want of vacancies shall contain an extract of second proviso to sub-rule(b) of rule 7 Part II, Kerala State and subordinate Service Rule, 1958.

4. The orders in respect of Last Grade Servants will be issued separately.
