**ORDER**

In the Government Order read as 4<sup>th</sup> paper above, sanction was accorded for exercising option for the Family Benefit Scheme till 28-2-1979. Since then several representations have been received from the employees requesting to extend further the period for exercising option for the Scheme so as to get one more chance to join the Scheme as they could not join the Scheme due to some or other reasons. Government, after considering these representations sympathetically, are pleased to order that the time granted for exercising option to join Family Benefit Scheme is extended upto 31-3-1980 subject to the following conditions:-

- (i) The employees so joining the Scheme should exercise option with effect from 1-2-1979 and arrears should also be paid from that date to the date of their joining, and
- (ii) Payment of arrears may be made in instalments. Arrears at the rate of one month's contribution or multiples thereof may be deducted along with the regular monthly subscription till the arrears are cleared.

The option and nomination filed by the Non-Gazetted Officers will be countersigned with date by the head of office and recovery should be started within one month's time at the latest.

The heads of departments and offices will ensure that the contents of this G.O. are brought to the notice of all the employees including those on deputation, so that all the employees who are desirous of joining the Scheme, may do so within the stipulated period; i.e. on or before 31-3-1980.
