GOVERNMENT DECISION 5 AND 6- ORDERS ISSUED.

ORDER

As per Rule 14 E Part 111, Kerala Service Rules, aided school service prior to enter in Government service qualifies for pension. In Circular No.76-83-Fin.Dated 23-11-1983, instructions were issued to the effect that in the case of officers of Departments other than the education department information regarding the Governments or managers share of Provident Fund, contribution and details of service may be obtained from the concerned officers of the Education Department and required certificate recorded in the Service Book by the Head of the Department /pension sanctioning Authority, the Heads of Department /pension Sanctioning Authority have it issue the certificate as contemplated in Government Decision No5&6 under Rule 14 E Part 111 Kerala Service Rules. But it may not be possible for the Head of Departments/pension Sanctioning Authority to verify the original records such as attendance registers, acquaintance rolls pay bills etc, to issue the certificates. Hence the Government after detailed examination are pleased to issue the following orders modifying Government Decision No5&6 and inserting Government Decision No 6 A.

1. After the words "Pension Sanctioning Authorities" occurring in the second sentence of Government decision No. 5 and the first sentence of Government Decision No 6 the following shall be added:

"or Head of Departments".

2. The following shall be inserted as 6 A after Government Decision No 6.

"6 A for recording the certificates as in Government Decision *&6 above certificate duly countersigned by the D.E.O. can be relied upon. In such cases it should also be recorded that the certificate is as per letter No.....dated
Of the D.E.O.....(place).

Inc case where the services in the aided schools have been entered in the service Book under proper authentication, further certificate to the effect is not necessary."
