**RULES**

(C.S NO 15/87)

1. *Short title and commencement (1)* These rules may be called the Kerala Service (Amendment ) Rules 1987.

(2) They shall be deemed to have come into force with effect from the 17th day of November 1969.

2. Amendment of the rules – In Part III of the Kerala Service Rules, in sub-rule (6) of ruke 90, after Note 2, the following note shall be inserted, naley:--

“ Note 3 - the terms sons and daughters occurring in clauses c and d of sub rule (6) include posthumous and posthumous daughters”
