**ORDER**

In the G.O CITED Government have delegated the power of sanctioning pension to the subordinate officers , In the light of this GO the director of public Instruction is the Pension Sanctioning Authority respect of all Gazetted Officers working under him . The deputy Directors at the District level are the Pension Sanctioning Authorities of all nongazetted officers. The pension of Headmasters and Assistant educational officers is now being sanctioned by the Director of Public Director of Public Instruction .

2 The Director of public Instruction in his letter cited has requested to issue necessary orders delegating the power of sanctioning pension of Headquarters / Assistant Educational officers to Deputy of the District level to expenditure the disposal of pension cases

3 Government after examining the question in detail are pleased to delegate further the power of sanctioning pension to the Deputy Directors of Educational of District level in the case of Headmasters Assistant Educational officers .

4. Necessary amendments to the relevant rules in part IIIKSR and KTC will be issued separately,
