S.R.O No. 100/71—In exercise of the powers conferred by Sub-section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) read with section 3 thereof, the /government of Kerala hereby make the following amendments to the Special rules published under G.O.(P) No. 464/ Public (Rules) Department dated the 28th November 1966 in part I of the Kerala Gazette No.49 dated the 13th December 1966, as subsequently amended, namely:-

AMENDMENTS

In the said rules,

1. in rule:-

(a) in category IA following shall be inserted at the end, namely:-

“Administrative Assistant. Office of the Chief conservator of Forests”

(b) in category 2, the words “ superintendent, Office of the director of Public Relations” shall be deleted.

2. in the table in sub-rule (a) of rule 2-

(a) After the existing entries under the headings “Categories” and “ Method of Appointment” relating to category IA, the following shall be inserted namely:-

“Administrative Assistant,
Office of the Chief Conser-
vator of Forests

By Promotion from Senior
Superintendents in the
Forest Department.

(b) in category 2 the item “ superintendent, Office of the director of Public Relations” and the entry against it under the heading “ Method of Appointment” shall be deleted.

Explanatory Note

(This note is not part of the amendment but is intended to indicate its general purport)

The qualifications and method of appointment to the post of Administrative Assistant, Office of the chief conservator of forests, have been laid down in G.O.MS. 333/69/ Agriculture Department dated the 4th September, 1969. It is necessary to include this post among the post in the Kerala General service coming under the Special rules issued in G.O.(P) 464/66/PD dated 28-11-1966. Consequent on the merger of the Ministerial staff of the Directorate of Public Relations with the corresponding posts in the General Secretariat, the post of superintendent. Office of the director of Public Relations has to be deleted from the Special rules for the Kerala General Service. This notification is intended to amend the special Rules for the Kerala General Service for achieving the above objects.
