Read:- Lr.No.KWA/HO/SP -11418/91/LIME, dt. 14.3.93 from the Managing Director Kerala Water Authority addressed to the Secretary, Local Administration Department.

ORDER

The Managing Director, Kerala Water Authority invited tenders for the supply of hydrate lime for the treatment of Water Supply Scheme during the year 1992-93 Vide tender No KWA/Ho/SP4/92-93 dated 12-12-91 and the offer received from M/S.Lime and Allied Industries, Thrissur being the lowest was accepted. at the firm did not supply the commodity for executed the agreement. This backing out of the firm from the lowest officer caused much inconvenience to the Kerala Water Authority

2. Since this was a branch of contract on the part of the firm, Government issued a show Cause notice to the firm in Letter No 6830/B4/93/SPD dt.21.4.96 to show cause, if any, within 15 days from the date of the receipt of the notice as to why the business dealing with the firm should not be banned for the aforesaid breach of contract. The explanation furnished by the firm is not satisfactory and not acceptable. Further the Water Authority has reported the the backing out of the firm occurs frequently in the receipt past and due to this they were put into many difficulties in running the most essential water treatment plants, Moreover the Kerala Water Authority in their 12th meeting had resolved to blacklist the firm for a period of 3 years and to remove their name from the list of approved firms for the supply of lime.

3. In the above circumstances, Government in exercise of power conferred under Para 95 of the Stores purchase Manual decided to blacklist the firm M/S Lime and Allied Industries , Mala, Thrissur,(680732) for a periods if three years from the date of this orders during which period Government Departments, Statory Bodies, Corporatiomn,Authonomous Bodies and Public Sector Undertaking under government will not enter into or involve in any business dealings with the aforesaid firm or its properties and they order accordingly.
