ORDER

Read:- 1. Government circular No. 73810/SD3/75/FD dated 22-11-1975
2. Memorandum dated 10-10-1975 from the Kerala N.G.O. Union.

In the circular read as first paper above , Government have issued the following clarification:-

‘Candidates who had passed the following three paper of the Account Test (Lower) before 1-4-1963 would be deemed to have completed the Account Test (lower) from 1-4-1963 onwards.

1. T.S.R. & C.S.R. (Excluding T.A.Rules)
2. Travancore F.&A.Code
- 3 Introduction to India Audit and Accounts, Part I and III

Candidate who had completed the Account Teat (Lower) by passing the above three papers during the period from 1-4-1963 to 31-12-1963 would also be deemed to have completed the test. From 1-1-1964 persons who were in services before that date and who had not completed the Account Test (Lower) for having not passed in one or two of the above papers would have to pass the corresponding paper in the new test and also paper IV of the new test. Those who had not pass any of the three papers would have to pass the new test in full.

It has come to the notice of Government that persons in service on 1-4-1963 who had not completed the Account Test (Lower) for having not passed in one or two of the papers mentioned in Para 1 above but who had since passed the corresponding papers in the new test, were promoted by certain heads of departments even through they have not passed paper IV of the new test. Representations have been received that the concerned heads of departments are taking action to revert such persons now and that since such reversions will be quite hard , the persons concerned may be allowed to continue in their present posts and allowed temporary exemption to pass paper IV of the new test.

Government have examined the question and they are pleased to order that persons of the category mentioned in Para 2 above will be given temporary exemption for a period covering 2 chances of Account Test from passing paper IV of the new test.
