ORDER

In the G. O. read as third paper it was ordered among other things that the services of the physically handicapped provisional (temporary) employees who were appointed by direct recruitment under rule 9 (a) (i) of the Kerala State and Subordinate Services Rules. Part II and who were in service on any day from 22-12-1973 to 1-1-1974 would be regularised. In the G.O read as fourth paper it was ordered, inter alia, that the five year rule stipulated in the G. O. read as Ist paper for inter-district transfer of district wise recruits would be made applicable to persons regularly absorbed in Government Service as per G.O. (P) No. 126/75/PD dated 18-6-1975 and G.O. (P) No 67/76/PD dated 25-2-1976 and also to persons appointed under the dying in harness scheme against ministerial posts coming under the scheme of district-wise recruitment in the G. O. read as fifth paper, Government clarified that the orders issued in G.O. read as fourth paper would come into operation in the case of a person appointed as L.D. Clerk under the dying in harness scheme only after the candidate is posted to the unit to which he has opted for being appointed.

2. In the letter read as sixth paper the Director of Employment has requested Government to consider whether a similar concession as allowed to candidates appointed under the dying in harness scheme (vide the G.O. read as the fifth paper) may not be extended to the employees whose services were regularised in pursuance of G.O. (P) No. 67/76/PD dated 25-2-1976.

3. Government have examined the matter and are pleased to order that in the case of physically handicapped provisional employees whose service were regularised in pursuance of the G.O. read as the third paper, the orders in G.O. (P) 72/76/PD dated 3-3-1976 will come into operation only after they are given an opportunity to opt to a particular district and are posted to the District opted by each.
