As doubts regarding the eligibility of provisional hands to T.A. , D.A. etc are likely to arise with the incorporation of the above Note, Government are pleased to issue the following as a ruling under Rule2, Part I, Kerala Service rules.

**RULING NO.55/87.**

" The Rules in part II, Kerala Service Rules relating to traveling allowance shall apply to the persons appointed to the service of the government temporarily under rules 9 of Part II of the Kerala State and Subordinate Service Rules also."
