ORDER

In the circumstances reported by the Director of Census Operations, Kerala, sanction is accorded for the payment of T.A at flat rates to the Supervisors and Enumerators to attend the training classes in connection with the 1981 Census enumeration, as given below:-

- (i) Rate of T.A to be paid to be
Supervisors and Enumerators
For attending training classes within a radius of upto 24 kms from their place of duty. Rs. 10 for each training class attended.
- (ii) Rate of T.A to be paid to the
Supervisors and Enumerators
For attending training classes Beyond a radius of 24 kms. From their place of duty. Rs. 15 for each training class attended.

2.The Charge Officers are permitted to draw the amount as advance and disburse it to the Supervisors and Enumerators in lump at the end of the last training class.

3. The expenditure will be incurred and got reimbursed from the Government of India according to the procedure prescribed in G.O. (MS) No.253/80/GAD dated 20-6-1980.
