ORDER

In addition to the existing economy restrictions Government are pleased to issue the following additional measures to regulate the Non-Plan expenditure in Government:-

- (i) No Minister, Government Officials and Officials in any State Government owned Public Sector undertaking/ Universities shall travel by any class other than economy class while performing journeys by Air, till 31-03-2002.
- (ii) No officer in Secretariat, Government Departments, Public Sector Undertakings, other State Government Institutions including Autonomous Bodies will use more than one vehicle Excess vehicle, if any, should be surrendered immediately.
- (iii) No officer in government/Public Sector Undertakings/Autonomous Bodies shall travel outside the State or abroad without priorapproval from Government,

These instructions will be scrupulously followed. Any laxity will be viewed seriously.
