NOTIFICATION

In exercise of the powers conferred on them by rule 30 of the Kerala Public Service Commission Rules of procedure published 1 Part IB of the Kerala Gazette No. 43 dated 2nd November, 1976 and all other powers there after enabling with the prior concurrence of the Government of Kerala, the Kerala Public Service Commission make the following amendment to the third proviso to rule 13 in Part I of the K.P.S.C Rules of Procedure:-

AMENDMENT

The Existing 3rd proviso under rule 13 of the K.P.S.C. rules of procedure shall be replaced by the following:-

1. "Provided further that a ranked list from which candidate is advised during the period of one year from the date on which it was brought into force shall be kept in force till the expiry of three years from the said date and in a case where no candidate is advised from the ranked list till the expiry of the said period of three years, the duration of the ranked list shall be extended by the Commission for further period of one year or (till at least one candidate is advised from the list whichever is earlier.)"
2. This amendment shall take effect on and from 4-8-1985.

Explanatory Note

This note is not part of the notification, but is intended to indicate its General purport.)

According to the 3rd proviso incorporated in rule 13 of the K.P.S.C. Rules of Procedure (vide notification issued on 8-8-1978 by the Commission), a ranked list from which no candidate is advised during the period of two years from the date on which it was brought into force, shall be extended by the Commission for a further period of one year or till at least one candidate is advised from the list whichever is earlier. Later, as per the amendment issued on 4.9.1984 to rule 13, the list existed as 4.8.1984, have been extended to three years. In the circumstances, the Commission decided to modify the existing 3rd proviso to rule 13 of the rules of procedure, so that a ranked list from the which no candidate is advised during the period of three years can be kept in force for a further period of one year or till at least one candidate is advised. The amendment is given

respective effect from 4.9.1985, with a view to making it applicable to all the ranked lists, the maximum period of validity of which have been extended for three years.

The Government has in their letter No.56595/SD4/86/GAD. Dt. 16.6.1986 communicated their concurrence to amend the proviso accordingly.

This notification is intended to achieve the above object.
