NOTIFICATION

S.R.O No439/78- In exercise of the powers conferred by subsection (1) of section 2 of the kerala public service Act 1968(19 of 1968) read with section 3 of thereof the government of kerala hereby make the following amendment to the kerala state and subordinate service rules 1958 namely;-

AMENDMENT

In part II of the said Rules in rule 14 after clause (c) of the following clause shall be inserted namely;-

“(d) Notwithstanding anything contained in this rules, posts to which appointments are made by direct recruitment from a common ranked list prepared on the basis of a common tests or interview or both shall be grouped together for the purpose of observance of the rules relating to reservation of appointments”

Explanatory Note

(This note is not part of the amendment but is intended to indicate its general purport)

It has been brought to the notice of Government that the rules regarding communal reservation in public services may take a long time to produce the result aimed at if as at present they are applied to individual post or post the number of vacancies of which is less than 20, since the communal rotation as provided under General Rules 14© cannot be observed fully in such case for wants of the required number of vacancies. To overcome this problem and also in the interest of administrative expediency the public service commission has decided to group posts of similar status an requiring the same qualification for purpose of recruitment conduct common selection to such posts and to apply the rules of communal reservations to the groups so formed. It has however been pointed out that the principles of reservation cannot be applied to recruitment from a common ranked list unless general rules 14 according to which the said principal shall apply only to a particular service , class or category is suitably amended. This notification is intended to achieve the above object.
