ORDER

In the G.P. Read as forest paper above it was ordered that officers of the Mysore State transferred to Kerala since 1.11.1956 will be governed by the same conditions as those applicable to Madras Officers who were transferred to Kerala (vide para (i) d) But it has now been decided in consultation with the Government of Madras and Mysore that Officers who were in the first instance allotted from Madras to Mysore and subsequently transferred to Kerala will be treated as having been allotted to Kerala direct and similarly those who were in the first instance allotted to Kerala and subsequently transferred to Mysore will be treated as all tied to Mysore direct. This decision has the approval of the Government of India. Thus the Mysore officers transferred to Kerala since 1.11.1956 will have will has all the conditions of service as the personnel allotted from Madras to Kerala on 1.11.1956 and Government order accordingly the G.P. SRN2 13545/57/PD dated 26.12.1958 is modified to this extent.
