ORDER

In the letter read as send paper above, it was reported by the Director of Harijan Welfare that a sum of Rs.450.07 had to be paid to the party towards transporting charges for transporting 600 cft of Second Class of teakwood purchased by the District Welfare Officer, Trivandrum when the Government Timber Depot, Veeyapuram to the concerned Model Welfare cottages in Trivandrum District. In the letter read as third paper above, the Chief Conservator of Forests has reported that if the work were got executed by the Forest Department, only Rs.305.40 would have to be paid. The Director of Harijan Welfare, who has been consulted, regarding the high cost of transportation charges, explained in his letter read as fourth paper above, the circumstances for incurring the transportation charges in excess of the charges assessed by the Chief Conservator of Forests.

2. In the circumstances stated by the Director of Harijan Welfare in the letter read as fourth paper above, the loss of Rs.144.67 (Rs. One hundred and forty four and nP. Sixty seven only) sustained by Government in the transportation of timber logs in question is condoned and the action of the then Director of Harijan Welfare in having done the work through negotiation and paid the amount of Rs.450.07 (Rs, Four hundred and fifty and nP. Seven only) is ratified.

3. The Director of Harijan Welfare will get such works done in future only through the Forest Department.
