The Departmental schedule of rate for the conveyance of materials by lorry lead and for the transport of timber of lorries are higher than the rates existing in the P.W.D

According to the sales now sanctioned vide G.O 21-2894/67/Agri. Dated 17.1.67 in also more than that of the P.W.D schedule of rates. The rates now sanctioned by Government are as follows:-

Land Up to 20 km

Main road Rs. 25 per KM for 3 ten leads

Coupe road Rs. 2.25 per KM do

Land ever 20 KM

Main road 3-1-25 N' for 3 ten

Coupe road Rs. 2.25 do.

P.W.D rates as per revised schedule of rates are up to 3 tones as Rs. 0.60 per K.M

Over 3 tones Rs. 0.90. per Km

Therefore the rates now sanctioned are more favorable than P.W.D. rates, leading charges now sanctioned are 20% more than the old rates i.e. 1. 20 per 100 Cft. Unloading charges are Rs. 2/- per Cft. These work out to Rs. 2.52 and 0.70 respectively person. So it does not appear necessary to adopt the P.W.D schedule rates instead of the Forest Department.
