ORDER

In the G.O. read as first paper above as modified by the G.O. read as second paper above, Government have ordered among other things that permanent Government Servants who are permitted by competent authority to apply for and take up appointment under another State Government of the Government of India will be allowed to retain their lien in the State Service until they are confirmed under other State Government/Government of India or till five years from the date of relief whichever is earlier. Nonpermanent hands so permitted may revert to this Government service at any time during a period of two years from the date of relief and at the end of two years they will be deemed to have resigned from Government service if they do not so revert. In the G.O. read as third paper above, Government have ordered that the concessions regarding retention of lien ordered in the G.O.s. read as 1st and 2nd papers above will be extended to the officers who take up appointment under the corporations, Government Companies (fully shares) and Universities in the State. In the G.O. read as fourth paper above as distinct from the first three G.Os. read above Government have issued certain guide lines for the grant of leave and permission to Government Servants to take up private employment in Kerala State, other States in India and especially in countries outside India. Bu the G.O. read as fifth paper above, statutory validity has been given to the orders in the G.O. fourth cited amending the Kerala Government Servants Application for posts (Private Employment and Government Service) Rules, 1958.

2. An instance has been noticed where an officer of Government granted leave without allowances for 3 years with permission to take up appointment in a University in the State. This is not in accordance with the provisions of G.O. (P) 124/PD.dated 24-3-1966 as amended by G.O.(P) 11/69/PD dated 7-1-1969 and G.O (P) 330/PD. Dated 31-10-1969 which allows only retention of lien in State Service (For the periods mentioned therein) and does not provide for grant of leave to such officers for the period.

3. Government are pleased to clarify in respect of Government servants permitted to take up appointments under other State Government s Government of India, Corporations, Government Companies, (fully owner and those in which Government hold 50% or more of shares) and Universities in the State, the orders applicable are those in G.O.(P) 124/PD dated 24-3-1966 G.O.(P) 11/69/Pd dated 7-1-1969 and G.O. (P)330/PD dated 31-10-1969 and not those in G.O. (P) 274/70/Fin dated 29-4-1970 and G.O.Ms. 80/75/PD. Dated 16-4-1975. The latter two G.Os and exclusively intended for those who apply for permission to take up private employment after availing leave.

4. Cases in which erroneous orders such as those mentioned in Para 2 above have been issued, should be reviewed.
