ORDER

In the G.O. read as above, Government have prescribed a pass in the Malayalam Typewriting, K.G.T.E (Lower) or its equivalent as an Additional Qualification for recruitment to the posts of English Typist in Government Service. Since the personnel relieved from the Defense Forces cannot be expected to possess the Malayalam Typewriting qualification at the time of recruitment, the question of relaxing the prescribed qualification their case has been examined by the government in consultation with the Kerala Public Service Commission. Accordingly, the Government are pleased to issue the following orders:-

1. Ex- Service men will be exempted from Malayalam Typewriting qualification for recruitment to the post of Typist in Government Service e subject to the condition that persons so appointed will acquire that qualification before completion of probation.
2. Service as Clerk-cum- Typist in the defense forces for 15 years will be deemed as sufficient qualification to apply for the post of Typist in Government Service subject to the condition that persons so appointed will acquire the required Malayalam Typewriting qualification before completion of probation.
