

100 Days programmes**

**1. Man animal conflict-Autherisation to kill crop raiding wild boars:**

Recommendation of the committee constituted by the Government to study the problem of man wild conflict regarding culling of crop raiding wild boars will be accepted by the Government and action ensured .

**2. Radio Collaring of Elephants:**

Radio collaring of crop raiding elephants to track their movement as a measure to mitigate the problems of man wild conflict will be implemented.

**3.Establishment of Five Rapid Response Teams to Drive back the  
crop raiding elephants :**

Five numbers of sufficiently equipped Rapid Response Teams in the elephant prone areas such as Sulthan Batheri, Nilambur, Kannur, Palakkad and Ranni to drive back the crop driving elephants will be set up.

**4. Pension Adalath in Forest Department:**

Adalaths for the settlement of pension cases of all offices coming within the jurisidiction of the circles in the State will be conducted in which stress will be given to speedy settlement of all disciplinary/vigilance cases.

**5. To make Thekkady and Gavi free from plastic:**

Special drive will be conducted to make the Thekkady and Gavi and other tourist destinations of the Forest and Wild Life Department completely free from plastic.

**6. No Objection Certificate to wood based industries:**

A minimum number of 2000 applications for the Non Objection Certificates from the Forest and Wild Life Department will be cleared during the next 100 days, by holding Special Adalaths for the purpose.

**7. One day awareness camp for owners and mahouts on shelter, health care and management of captive elephants:**

One day awareness camps will be conducted in selected three venues in the state so as to sensitise the owners and mahouts of captive elephants on the issues related to proper shelter, health care and smooth management of captive elephants .

**8. Sandal Oil Extraction Unit at Marayur:**

Sandal oil extraction unit at Marayur will be operationalised by the Kerala Forest Development Corporation
