### ORDER

In the G.Os. read as first and second papers above, orders were issued for making substitute appointments on daily wages on daily wages in the casual and other leave vacancies of less than 3 days duration in respect in respect of Full Time Contingent Sweepers/Cleaners. The Director, N.C.C. in his letter read as third above has stated that the full-time Sweepers in his department are borne n establishment and has, therefore, requested Government Orders enabling him to employ substitute on daily wages against the casual and other leave vacancies of full time sweepers (irrespective of Contingent or Establishment) of less than 30 days duration subject to the conditions stipulated in the above Government Orders.

Government, after due consideration, are pleased to order that the Heads of Departments can employ substitutes on daily wages against the casual and other leave vacancies of less than 30 days duration in respect of Full Time Sweepers/Cleaners in Contingent or Regular Establishment in relaxation of economy orders subject to the condition that this arrangement should be a resorted to only when it is absolutely and in offices where there is only one post of full time Sweeper/Cleaner and no part time Sweepers/Cleaners in existence.
