ORDER

As per the G.O. read as first paper above, sanction was accorded to start a Forest School at Walayar, with a 'Board of Control' with the Chief Conservator of Forests as President, Principal, Kerala Forest School Walayar and All Conservators of Forest as Members, to discuss such issues of problems of administration as are considered beyond the scope of the Principal alone. As per the G.O. read as 2<sup>nd</sup> paper above, sanction was also accorded to start a new Forest School at Arippa, which started Functioning from 1-9-1981, but there was no mention in the above Government order about the "Board of Control" to the Institution.

2. The Chief Conservator of Forests (Development) as per his letters cited has proposed that the composition of the existing 'Board of Control' for the Kerala Forest School, Walayar may be changed so as to suit to be functioned as a "Board of Control for both the Forest Schools at Walayar and Arippa.

3. Government have examined the proposal of the Chief Conservator of Forests (Development) in detail and are pleased to constitute the 'Board of Control' for the Kerala Forest Schools at Walayar and Arippa, to discuss such issues or problems of administrations as are considered beyond the scope of the Principals of these Schools, with the following composition:

Chairman	-	Chief Conservator of Forests.
Convenor	-	Conservator of Forests, Working Plan and Research Circle, Trivandrum.
Members	-	The Principal, Kerala Forest School, Walayar, The Principal, Kerala Forest School, Arippa. All Conservators of Forests.

3. The 'Board of Control' shall meet normally once in an year.
