ORDER

In the Government Order read, the area of sweeping and the rate of remuneration of part-time contingent employees were revised as follows:-

Area to be swept/cleaned	Pay	DA	Total
100 sq. metres & above but below 400 sq. metres	Rs. 225	64	289
400 sq. metres & above but below 300 sq. metres	Rs 283	70	353

It was also ordered in the G.O. that the post if part-time Sweeper need not be created in small officers where the area to be Swept/cleaned is below 100 sq. meters.

2. It has come to the notice of Government that the implementation of the orders in the G.O. dated 16-8-1986 will create hardship to those whose area of sweeping work is between 200 and 400 sq. metres and to those whose area of sweeping work is below 100 sq. metres, if they cannot be accommodated against posts which carry the same amount of remuneration as they were getting earlier, In such cases the incumbents concerned deserve protection in the emoluments they were drawing before the G.O. dated 16-8-1986 was issued.

3. Accordingly Government are pleased to clarify that the part-time contingent sweepers/cleaners who joined service prior to the issue of G.O. (P) 550/86/Fin. Dated 16-8-1986 will be given protection to the pay drawn by them so along as they occupy the post. The Heads of Department shall however transfer such employees against arising vacancies in the big category in the same offices or nearly offices in the same area an I whenever they vacate the posts, the new incumbents will be given emoluments only as per the specification in the G.O. dated 16-3-1986.
