### **ORDER**

Under the order issued in G.O. (P) No. 498/61/Rev. dt 17-5-61 the District Collectors have power to transfer Government lands between departments of the Government upto a limit of 2 acres provided the market value of the improvements does not exceed Rs. 2500/- Similarly the Board of Revenue is competent to transfer land upto a limit of 5 acres provided the market value of improvements does not exceed Rs. 5000 . The above powers shall not be exercised by the District Collectors and Board of Revenue in the case of transfer of Government lands within the corporation of Trivandrum and the Municipalities and the lands in the reserve forests. For the expeditious disposal of business the Board of Revenue has proposed that the powers delegated to the District Collectors and the Board of Revenue may be delegated to the Revenue Divisional officers and the District Collectors respectively and that the powers to sanction transfer in cases where the extent is below 10 acres and the market value of improvements does not exceed Rs. 10,000/- may be delegated to the Board of revenue.

2. Government have examined the proposal of the Board of Revenue and are pleased to accept the same .

Rule 1 of the rules issued in G.O. (P) 498/61 /Rev. dt. 17-5-61 is revised as follows:-

“Rule 1. The Transfer of Govt. lands and improvements thereon from one Government Department to another shall be ordered by the Revenue Divl. Officers, the Collectors and the Board of Revenue as shown below”

i) Revenue Divisional Officers. Upto a limit of 2 acres in each case provided the market value of improvements, if any , thereon does not exceeds. Rs 2, 500/-

ii) District Collectors . Above 2 acres upto a limit of 5 acres in each can provided the market value of improvement, if any, thereon does not exceed Rs. 5,000/-.

iii) Board of Revenue, Below 10 acres provided the market value of improvements, if any, thereon does not exceed Rs , 10000.

Note: 1. The above powers shall not be exercised by the Revenue Divisional officer, the District Collectors and the Board of Revenue in the cases of transfers of Government

lands within the corporation and the Municipalities of the State and the lands in the Reserve Forests.

Note: 2. When land in the possession of one Department is to be transferred to any other Department such transfer may be made by the Revenue Divisional officer, No Collectors or the Board of Revenue as the case may be, in consultation with the Department concerned.

iv) All cases not covered by the above delegation shall be submitted to Govt. for orders''

3. The Rules issued in G.O. (P0 498/61/RD /17-5-61 stand modified to this extent.
