ORDER

In the Government Order read as Ist paper above orders were issue that the 113 acres of land in Thoppipala area in Aiyappencoil Range will be allotted at the rate of one acre each to the Poor landless people of the locality. Out of the 113 acres of land mentioned above an extent of 48.70 acres have been taken charge of by the Special Deputy Collector , Idukki for being allotted to the evictees from Idukki Hydro Electric Project area as ordered in the Government order read as II paper above . In the Government Order read as third paper above 2 acres of land has been assigned to one Smt. Janaki Amma and as per the Government Order read as IVth paper above an extent of 1.50 acres of land has been ordered to be assigned to Shri. Path rose Joseph.

In the letter read as Vth Paper above the District Collector Kottayam has requested orders for utilizing the balance area of 64.30 acres of land at Thoppipala for allotment to the evictees from Idukky Hydro Electric Project area in modification to the orders issued in the Government orders read as Ist paper above . He has also reported That out of the above area in extent of 7.41 acres is under encroachment. The District Collector. Idukki in his letter read as VIth Paper above has reported that there is a proposal for the transfer of 2 acres of land foe one lakh housing scheme and an extent of 11/2 acres of land to the Harijan Welfare Department for Murikkattumuri tribal school. In the circumstances the balance area of land in Thoppipala after the assignment already sanctioned and leaving the area covered by the two pending proposals mentioned above will be available for rehabilitation of Idukki evictees

Government are pleased to order in partial modification of the Government order read as first paper for utilizing the balance area of 54.30 acres of land available in Thoppipala in Udumbanchola Taluk for the rehabilitation of the Idukki evictees.

The Chief Conservator of Forests will make necessary arrangement for the land being made available to the Special Deputy Collector, Idukki after removing the encroachment in the 7.41- acres of land immediately.
