ORDER

In the Government Order read above sanction was accorded to lease out 2 cents of forest land each at Vazhachal, Ambalappara and Kollathirumedu in Chalakudy Divisions to S/Sri.K.E. Kunhandy and K.C. Vasudevan, Contractors for conducting arrack shops for the year 78-79 at a lease rent of Rs. 400/- (Rupees four hundred only) per cent per annum. The period of the lease expired by 31-3-1979. It was ordered therein that in case the lease period was to be extended further the Chief Conservator of Forests would forwarded his recommendations for the purpose before termination of the lease period.

- 2. In the letter read as 2nd paper the Chief Conservator of Forests, while recommending extension of the lease period of the above lands for the year 80-81, has reported that no action was taken by the Conservator of Forests, Trichur for the eviction of the leases from the area a termination of the lease period ie. 31-3-1979 and that the leases were allowed to continue to occupy the lands for the period 79-80 after realizing lease rent at the rate of Rs.500/- (Rupees five hundred only) per cent per annum, without obtaining Government sanction.
- 3. After careful examination of the case Government consider that the action of the Conservator of Forest, Trichur in having permitted the lessees to occupy the land during 79-80 without Government sanction was irregular. The Chief Conservator of Forests will take suitable action against the Conservator of Forests for the irregularity. Government also order that lease rent for the land at the rate of Rs. 1000/- (Rupees One thousand only) per cent per annum will be recovered from S/Sri.K.S. Chathunny and I.V.Govindan for the year 1979-80.
- 4. Sanction is also accorded for leasing out 2 cents of land each at Vazhachal, Ambalappara and Kollathirumadu to Sri. K.S.Chathunny, Arrack Shop Contractor, Chalakudy for the year 80-81 for running arrack shops on realization of lease rent at the rate of Rs.2670/- (Rupees Two Thousand six hundred and seventy only) in lump for each plot subject to the terms and conditions specified in the Government order read as 1st paper.
