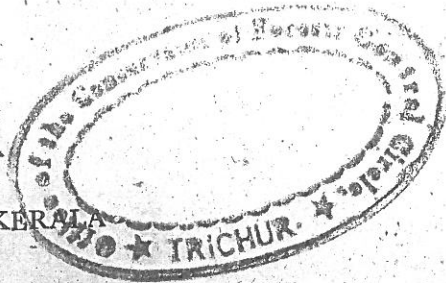

ORDER

In the Government order read as first paper above, orders have been issued for reckoning special pay during leave for calculation of average emoluments for pension.

2 The Accountant General (A & E), Kerala in his letter read as second paper above has sought certain clarification on the restriction imposed in the order read as first paper above.

3. Government after having examined the matter in detail are pleased to issue the following clarification in amplification of the Government Order read above.

4. The benefit of reckoning of special pay for calculation of average emoluments for purpose of pension while on leave with or without allowances is restricted, only to those who are in receipt of Cl. I (a) Special pay which are admissible during periods of leave as per Note I below Rule 93 Part I K. S. R.

5. All other kinds of special pay which are now admissible for pension will continue to be reckoned for pension if the employees are not on leave. These orders take effect from 8-5-1990.

6. Necessary amendment to Note I under Rule 63 part III K. S. R. will be issued separately.
