Accountant General (A&E), Kerala.

In the G.O. read above, it has been ordered that recovery of leave salary/
pension contribution at the revised rates (based on the new scales of pay)
would be made from 1-7-1988 or from the date of effect of fixation of pay of
the employee concerned in the revised scale.

2. The Accountant General, Kerala in his letter read above has brought
to the notice of Government that in certain cases foreign employers disagree
to remit penal interest on the arrears of leave salary and pension contribution
from 1-11-1989 even when they remit the arrears much later than 1-11-1989
on the contention that Government Orders for remittance of leave salary and
pension contribution at the revised rates were issued only on 4-4-1990.

3. Government, therefore clarify that penal interest will be charged
on the arrears from 1-11-1989 or from the date of option of the revised scale
whichever is later.
