ORDER

In the Government Order read above, orders were issued introducing an Ex-gratia pension scheme for State Government employees who have lost their eligibility for minimum pension on account of not having the minimum qualifying service. The Accountant General as per letter read as second paper above has suggested clarification/modification on certain points relating the above pension scheme.

Government have examined the matter in detail and are pleased to issue the following modification/clarification.

Para 1 (c)

Those employees come under this scheme shall be eligible for the normal Death-cum-Retirement Gratuity as per the existing rules.

Para 3

The papers relating to the ex-gratia pension need be sent to the Accountant General by the pension sanctioning authorities instead of the Head of Department.
