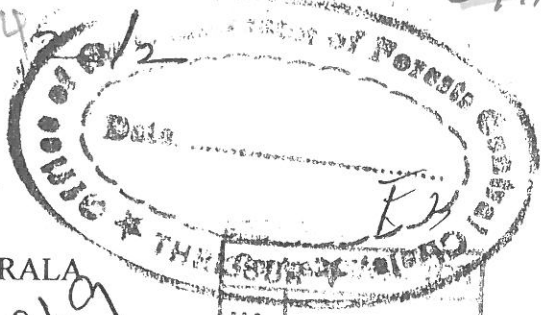

ORDER

As per the Government Order read as first paper above, Government have introduced an Ex-gratia Pension Scheme for State Government Employees who are not eligible for minimum pension on account of not having the minimum qualifying service. Thereafter, representations are being received by Government to extend the benefit of the above Pension Scheme to teaching and non-teaching staff of Aided Schools/Private Colleges, employees of local bodies, permanent labourers, etc. whose pay and allowances are governed by the provisions of Kerala Service Rules.

Government have examined the matter in detail and are pleased to order that all categories of employees coming under the direct payment system in aided educational institutions and employees of local bodies, permanent labourers, etc. who are governed by provisions of Kerala Service Rules shall be eligible for the Ex-gratia Pension Scheme subject to the conditions stipulated in the Government Orders read above.

This order will come into effect from 1-10-1999.
