In the G.O. referred first above, Government have constituted a high level Advisory Committee for the speedy settlement of pensionary claims and for reviewing long pending cases. The Principal Secretary (Finance) is the Chairman of the Committee and Accountant General (A&E), Kerala and Secretary (P&ARD) are the members. In the G.O. referred third above, the work relating to the speedy settlement of Provident Fund claims is also entrusted to the above High Level Advisory Committee for reviewing long pending Provident Fund cases.

It has become necessary to take effective steps to check delay in settling Provident Fund claims and to redress the grievances of the subscribers. Government are pleased to issue instruction to the Heads of offices to monitor this item of work attended to by the Accounts Section of each office to expedite the settlement of Provident Fund claims in consultation with Accountant General under intimation to Government.

As regards Provident Fund accounts maintained by the Director of Public Instruction special attention should be given for the speedy settlement of Provident Fund claims by the concerned officers under the Directorate of Public Instruction.
