State Life Insurance Scheme was made compulsory to State Government employees from 1976 and there was disparity in the insured sums between male and female lives. This disparity was eliminated as per the Government Order read as 2nd above. But these orders were took effect from 1-6-1988 i.e. the date of the issue of the orders. Hence the disparity mentioned above for the period from 1976 to 16-11-1988 still existed, since the table of benefits was not given retrospective effect. The Director of Insurance, Thiruvananthapuram vide his letter read as 3rd above, has forwarded proposals to do away with these disparities.

Government have examined the proposals in detail and are pleased to accord sanction to give retrospective effect to the Government Order dated 16-11-1988 subject to the condition that when this effected old cases which are alive will be settled as per the revised schedule but settled cases will not be reopened as per the revised schedule.
