ORDER NO.H4-30288/99 DATED 5-10-1999

Government in their order read as 3rd paper above, have specified the upper monetary limit for sanctioning Temporary Advance/Non-refundable Advance from General Provident Fund by different categories of Officers in various departments. Government have also ordered that the categorisation of officers and monetary limit fixed now shall be in supersession of all existing orders issued in the matter and Heads of Departments shall issue an order specifying the designation of officers under their control to be included under the categories mentioned in the Government Order 3rd above. As such orders revising the upper monetary limit for sanctioning Temporary Advance/Non-Refundable Advance from the General Provident Fund by various categories of officers in the Forest and Wildlife Department, in supersession of all existing orders were issued vide reference 4th cited. In partial modification of these orders, the following orders are issued as no officers under category I and II were included earlier.


