

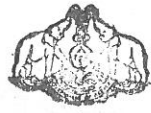

ORDER

As per Rule 44 of Part I Kerala Service Rules House Rent Allowance is admissible during periods of leave. In Government Decision No. 1 below Rule 44 Part I Kerala Service Rules, it has been clarified that House Rent Allowance admissible under the orders issued from time to time will be payable during periods of all leave with allowance for the first four months of such leave. Government Decision No. 2 provides for the payment of House Rent Allowance to officers who go on commuted leave preparatory to retirement and who retire while on such leave.

2. The intention of Government is to restrict payment of House Rent Allowance to four months during periods of leave. The absence of time limit of 4 months in Government Decision No. 2 could be interpreted that House Rent Allowance is admissible for any length of period during commuted leave taken preparatory to retirement.

3. Government have, therefore, examined the matter in all its aspects and are pleased to modify Government Decision No. 2 under Rule 44 as follows :

4. Rule 44—Government Decision No. 2

“House Rent Allowance admissible from time to time will be payable to officers who go on commuted leave preparatory to retirement and who retire while on such leave subject to the limitation prescribed under Government Decision No. 1 above”.
