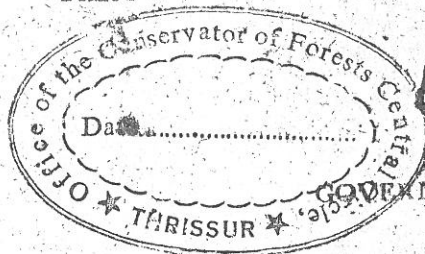

S. R. O. No. 75/93.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

(C. S. No. 4/92)

1. **Short title and commencement.**—(1) These Rules may be called the Kerala Service (Amendment) Rules, 1992.

(2) They shall be deemed to have come into force with effect from the 1st day of July, 1988.

2. **Amendment of the Rules.**—In Part I of the Kerala Service Rules, in the exception below rule 93 (ii) for the letters, figures and words "Rs. 1100 in the revised scale of pay ordered in G.O. (P) No. 515/85/Fin. dated the 16th September 1985" the letters, figures and words "Rs. 1370 in the revised scale of pay ordered in G.O. (P) No. 480/89/Fin. dated the 1st November, 1989" shall be substituted.
