ORDER

According to Rule 99(A) Part II, Kerala Service Rules, Travelling Allowance will be allowed to an officer on retirement to enable him to proceed to any place within or outside the State where the proposes to settle down after retirement. One of the conditions to be fulfilled for this purpose is that the officers concerned should furnish a declaration regarding the station where they intend to reside after retirement, six months before the due date of retirement, for claiming T.A for journeys to the place of residence, after retirement. But the officers usually fail to furnish the declaration within the time-limits prescribed due to some reason or other. Besides an officer who is to retire will normally consider the question of his residence after retirement, only just before or after the actual date of retirement, as he has to settle many things before taking a decision. Further it would not be possible to take such a decision within the time-limit in the case of voluntary retirement which also comes in the category of retiring pensions. Government are therefore receiving several representations for relaxing this time-limit and Government consider that the better course would be to take away this time-limit by amending the rule, instead of relaxing it every now and then. Accordingly, Government are pleased to issue the following notification.

In Part II of the said rules, in conditions (ii) of rule 99-A for the words “at last six months before the due date of retirement the words “before the retirement” shall be substituted.

Explanatory Note

(This is not part of the amendment, but is intended to indicate its general purport).

It has come to the notice of Government that officers usually fail to furnish the declaration required under rule 99-A Part II, Kerala Service Rules within the time-limit prescribed due to some reason or other Representations for relaxing this time-limit in several cases have been received and Government consider that the better course would be to take away this time limit. The amendment provided that the declaration under Rule 99A Part II, Kerala Service Rules need the submitted before retirement.
