Magistrate – Executive – Investiture of powers on Special Deputy Collectors for eviction of encroachments in Forest lands – Notified –

### ORDER

The following notifications will be published in the Gazette.

The Additional District Magistrates (Executive) concerned may define the local areas within which the Officers mentioned in the notifications are to exercise the powers notified.

### NOTIFICATION

#### I

In exercise of the powers conferred by Section 41 (1) of the Code of Criminal Procedure, 1898 (Central Act V of 1898), the Government of Kerala hereby withdraw all the powers under the said Code conferred on the following persons as Magistrates of the First Class in the Kottayam District as per notifications published under G.O.Rt.487/Home dated 27-3-1961.

1. Shri. A. Chakrapani, Special Deputy Collector and Deputy Conservator.
2. Shri. K.J. John, Special Deputy Collector and Deputy Conservator.

#### II

In exercise of the powers conferred by Section 12 (1) of the Code of Criminal Procedure, 1898 (Central Act V of 1898), the Government of Kerala hereby appoint the persons mentioned in column (1) of the schedule hereto attached to be Magistrates of the First class in the Districts specified against their names in column (2) thereof.

In exercise of the powers conferred by Section 37 of the Code of Criminal procedure 1898 (Cental Act V of 1898), the Government of Kerala hereby invest the first class Magistrates mentioned below with the following powers specified in the fourth schedule to the said code, as powers with which a Magistrate of the First Class may be invested by the State Government.

1. Sri. A. Chakrapani, Special Deputy Collector, Konni.	1) Power to require security for good behaviour in case of sadition, Section 108.
2. Sri. K.J. John, Special Deputy Collector, Kodanad.	2) Power to require security for good behaviour, Sec. 11 3) Power to make orders prohibiting repetition of nuisances, Section 143. 4) Power to make orders under section 144. 5) Power to take cognizances of offences without complaint, Section 190. 6) Power to sell property alleged or suspected to have been stolen etc. Section 524. 7) Power to try cases under section 124A of the Indian Penal Code.
