ORDER

As per orders issued in the Government Order read as 1st paper above general guidelines for accepting individual requests for exercising re-option for Pay Revisions had been issued. Based on the recommendations of Pay Revision Committee 1997 Government have modified the above practice and ordered in the Government Order second cited that re-option shall be allowed only in cases involving retrospective promotion and Court Orders.

The Deputy Accountant General (Accounts), Kerala have suggested to allow a general sanction for exercising re-option in cases employees are allowed retrospective promotion.

Government have examined the matter in detail and are pleased to order that in cases involving retrospective promotions, Government sanction is not necessary for allowing re-option. Such re-option should be exercised within three months from the date of order sanctioning retrospective promotion. Appointing Authorities should take a decision on such requests within one month from the date of receipt of request for re-option. It is also ordered that the facility to exercise re-option will be admissible only if the date of effect of retrospective promotion is prior to the date of option of the employees.
